**POLL RESULTS AT THE EXTRAORDINARY GENERAL MEETING  
HELD ON 31 OCTOBER 2018**

At the Extraordinary General Meeting of Dongyue Group Limited (the “**Company**”) held on 31 October 2018 (the “**EGM**”), a poll was taken for voting on the proposed resolution as set out in the notice of the EGM dated 15 October 2018 (the “**Notice**”). The poll result in respect of the resolution proposed at the EGM are as follows:

(b) any one director of the Company be and is hereby authorized on behalf of the Company to do all such acts and sign all such documents and to enter into all such transactions and arrangements as may be necessary or expedient in order to ensure smooth implementation of and to give effect to the Proposed Spin-off.		

**As more than 50% of the votes were cast in favour of the above resolution, the resolution was duly passed as ordinary resolution by the shareholders of the Company at the EGM.**

As at the date of the EGM, the total number of issued shares of the Company was 2,111,689,455 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolution at the EGM. There were no shares of the Company entitling the holders to attend and vote only against the proposed resolution or abstain from voting at the EGM.

The Company's Hong Kong branch share registrar, Tricor Investor Services Limited, was appointed as the scrutineer for the vote-taking at the EGM.
